- a. The gas portfolio manager position is a shared service utilizing both SDGE and SoCalGas cost centers. Cost can be incurred at either utility and are allocated based upon the shared services mechanism outlined in the workpapers, Ex: SCG-10-WP page 51. The corresponding cost center at SDGE, 2100-3328 increased over the same period by about the same amount, with a net decrease of \$18k due to miscellaneous purchased services timing.
- b. As stated in the testimony and workpapers of Karen Sedgwick, Exhibit SCG-10-WP, the base year was used to forecast labor charges and a 5 year average was used in forecasting non-labor from years 2010 through 2012.
