Customers qualify for up to \$200,000 in rebates per qualifying account, per program year. Customers applying for a gas measure must have a Southern California Gas Company account. Rebates will be paid on upgrading to or purchasing an approved natural gas energy efficient piece of equipment. Used or rebuilt equipment is not eligible. Customers with corporate (multiple) accounts cannot exceed \$200,000 per corporation or chain account customer, per program year.

EQUIPMENT REQUIREMENTS

- Equipment must meet technical requirements and be installed according to local building codes and ordinances and/or manufacturer's requirements.

C305	Griddle	Qualifying models must meet ENERGY STAR® specification. (ASTM Standard F1275)	\$125/per griddle
C306	Large vat fryer	Must meet or exceed heavy load cooking energy efficiency of 50% utilizing (ASTM Standard F2144)	\$500/per vat
C308	Rotating rack oven	Must meet or exceed heavy load cooking energy efficiency of 50% utilizing (ASTM Standard F2093)	Double - \$2,000/per oven
C310	Large conveyor oven (≥ 25" total conveyor width)	Must meet or exceed heavy load cooking energy efficiency of 42% utilizing (ASTM Standard F1817)	\$750/per oven

To qualify for a rebate, all purchase invoices or receipts must be dated between January 1, 2011 and December 31, 2011. All rebate items must be purchased, installed, and operational prior to submitting an application for a rebate. Qualifying rebate applications must be received at Southern California Gas Company's Central Processing Center or postmarked no later than December 31, 2011.
