SoCalGas Response 1:

IT Capital projects are not planned or recorded by functional area within SoCalGas. The information provided in this data request response, by GRC witness areas and by IT workpaper, are subsets of the overall IT portfolio of projects, as presented in the workpapers of Mr. Christopher Olmsted Exhibit SCG-26-CWP. For GRC purposes only, SoCalGas operational witnesses provide the business justification for projects that are primarily driven by their business needs, whereas the IT Capital Costs are included as part of the IT revenue requirement.
