### **QUESTION 1:**

What is the total amount of unspent Energy Savings Assistance Program (ESAP) funding from 2009-2019? By "unspent" we mean: funds that are (a) committed and spent, (b) committed and unspent, and (c) uncommitted. Uncommitted means the amount of funding that has not been otherwise committed to a purpose and would therefore be available for use.

### **RESPONSE 1:**

SoCalGas' total unspent ESA Program funding for 2009-2019 is \$361,020,430, calculated as follows:

As SoCalGas reported in Advice Letter (AL) 5111-A, a total of \$239,553,201 unspent from 2009-2016 were available as of the end of 2016, all of which has been authorized for use in the current program cycle via G-3532, AL 5256-A, and AL 5325.

SoCalGas has been underspent in the current cycle, as reported on Table 1, by \$54,005,061 in 2017<sup>1</sup>, \$36,101,833 in 2018, and \$31,360,335 in 2019 for a total of \$121,467,229 accumulated unspent from current cycle 2017, 2018, and 2019 budgets.

The prior-cycle unspent \$239,553,201 plus accumulated current cycle unspent \$121,467,229 yields a total \$361,020,429 unspent funds responsive to this question.

Of this amount, a total of \$12,422,821 of prior-cycle unspent funds have been spent in 2017, 2018, and 2019 as reported in Tables 1A of the respective annual reports. To date, no funds have been carried forward from year-to-year within the program cycle, thus the total amount of unspent, that has been spent, is \$12,422,821 responsive to part (a) of this question.

Subtracting the \$12,422,821 identified at item 1 above, from the total \$361,020,429 unspent carried forward from prior cycles or accumulated in current-cycle years 2017-2019, a balance of \$348,597,608 remains unspent, and is committed to the purpose of reaching SoCalGas' 2020 goal and providing retreatments.

All current year, prior-year, and prior-cycle funds authorized for use in the current program cycle are available for the purpose of reaching SoCalGas' 2020 goal, and \$0 are available other than for this purpose.

AL 5325, and AL 5256 & 5256-A authorized the carry-over of the unspent funds from the prior cycle for use in the current cycle.<sup>3 4 5</sup>

As a result, SoCalGas does not anticipate needing to access any unspent funds during the bridge period.
