



Zero-Percent On-Bill Financing

On-Bill Financing offers interest free financing for the purchase and installation of equipment covered by SoCalGas' energy efficiency programs.

Program Benefits:

- Zero-percent unsecured loans
- No origination fee
- No prepayment penalty
- Loan repayment conveniently added to your SoCalGas bill
- May help lower monthly natural gas usage

Who Is Eligible?

- Available for SoCalGas non-residential customers (including taxpayer-funded institutional customers) and owners of multifamily units who do not reside on the premise.
- Customers must have an active account with SoCalGas for a minimum of two years with the same business.

Project Eligibility

- Equipment must be installed at the meter of the account holder on record for which the loan is being made.
- Project must meet terms and conditions of one or more energy-efficiency programs offered by SoCalGas
- Estimated energy savings must be sufficient to repay the loan during repayment period:
 - 10 years maximum for business customers or
 - 15 years for Institutional customers
- SoCalGas account must be in good credit standing.
