2022 Business Rebate Application Now Available

The [2022 Energy Efficiency Rebates for Business application](#) is now available. Rebate amounts, program conditions, and eligibility requirements are unchanged from last year, except the following:

Infrared Film for Greenhouses: This newly added measure is offered at \$.02/sq ft.

Heat Curtains for Greenhouses: This newly added measure is offered at \$.30/sq ft.

Modulating Valves for Commercial Dryers: This measure is limited to 250 kits for coin operated laundries and 1000 kits for non-coin operated laundries.

Equipment Purchase Date: Equipment must be installed no later than one year after purchase.

Public Agencies: An additional 50% rebate* on top of standard rebate amounts is available for public agencies, such as public buildings, parks, and schools, until at least March 31, 2022. For example, a piece of qualified equipment that is purchased by this date, is installed at a public facility within 2022, and has a standard rebate of \$1,000, may receive an extra rebate of \$500 for a total rebate of \$1,500.

Contractor Partnership Platform Provides Installation Incentives to Residential Water Heater and Furnace Contractors

In collaboration with Affinity Engineering, we recently launched the Contractor Partnership Platform, a new program that provides residential contractors with a \$150 incentive for every Energy Star® tankless water heater and \$200 incentive for every Energy Star® central natural gas furnace they install.

As part of the program, participating contractors must attend a no-cost energy efficiency training session at least once every six months, which will be provided by Affinity Engineering.

The Contractor Partnership Platform is applicable for installations made at single family residences only. Installations made at multifamily and commercial properties do not qualify.

The program may also be combined with the [Home Energy Efficiency Rebate Program](#), which provides rebates, typically to the end user, for the installation of qualifying energy-efficient natural gas equipment in single family residences. Tankless water heater rebates range from \$600-\$1,000, while furnace rebates range from \$115 to \$1,000, depending on the units' efficiency level.
