

# SoCalGas LCFS Fuel Card Incentive Program

The SoCalGas Low Carbon Fuel Standard (LCFS) Incentive Program's period of accepting applications (Solicitation Period) will end 90 days from the Program Start Date Monday, June 30, 2025.

To participate in the SoCalGas LCFS Fuel Card Incentive Program (Program), applicants **MUST** purchase a New Class 8 heavy-duty RNG/CNG truck and/or a Class 8 heavy-duty hydrogen truck\* after the Program Launch Date and no more than 30 days after the Solicitation Period ends Sunday, September 28, 2025.

Applications received prior to the end of the Solicitation Period will be evaluated for qualification as set forth within these Program Rules, then either awarded (Funding Queue) or placed on the waiting list based on available funds.

Applicants in the Funding Queue will be notified within 10 business days of the end of the Solicitation Period. Applicants placed on the waiting list will be notified within thirty (30) days after the end of the Solicitation Period.

During the Solicitation Period, changes to applications will be limited to decreases in the number of SCG LCFS Fuel Cards applied for and/or application cancellations only.

Applicants must provide proof of purchase after Program Launch Date AND proof of truck delivery before SoCalGas will provide an SCG LCFS Fuel Card.

Cards will be provided on a first-come, first-served basis per the priorities set forth in these rules and until accumulated inventory funding is exhausted.

Applicants are allowed to use the SCG LCFS Fuel Card only at SoCalGas Heavy-Duty Public-Access Stations (SCG stations).

SoCalGas reserves the right not to renew the assigned SCG LCFS Fuel Card for any reason SoCalGas deems necessary, including lack of use and/or prohibited thirdparty sell or card reassignment. Any remaining funds not used at that point will go back to the Program for use by another qualified applicant.



If an SCG LCFS Fuel Card is lost or stolen, the Applicant must contact their SoCalGas representative immediately or email **[infolcfsip@socalgas.com](mailto:infolcfsip@socalgas.com)**.

SoCalGas will not be responsible for refunding any prepaid funds used on cards prior to the reported-lost-or-stolen date.

This Program may be modified or terminated at any time without prior notification.

## Priority in the Funding Queue will be given in the following order:

1. Date of application submission
2. Class 8 heavy-duty hydrogen truck purchases\*
3. Class 8 heavy-duty RNG truck purchases
4. Customer fleets of less than 10 vehicles
5. Customer fleets of 10 or more vehicles

Qualified Applicants who receive a SoCalGas (SCG) LCFS Fuel Card will be granted **one card for each newly purchased class 8 near-zero RNG/CNG truck** or Class 8 heavy-duty hydrogen truck\*, subject to verification of each truck purchase and delivery.

\* Hydrogen fuel cards will only be available once SoCalGas receives appropriate regulatory approvals to own and operate hydrogen fueling stations and such stations are constructed and begin operation.
