OBTAIN REBATESFOR NATURAL GAS EQUIPMENT

The Industrial Savings, Training, Assistance, Rebate (Industrial STAR) program offers rebates and support for common natural gas-saving projects.

WHO IS ELIGIBLE?

The Industrial STAR program supports customers with industrial food processing facilities who meet both of the following criteria:

- Receive natural gas service from SoCalGas.
- Pay the Public Purpose Program (PPP) Surcharge on their utility bills.
- NAICS codes 3111-3121 (Food Processing).

Additionally, all customers must have a signed and executed Industrial STAR Program Participation Agreement to participate.

Paid invoices are required for proof of purchase; additional documentation such as spec sheets may also be required for verification. Rebate applications must be submitted within 60 days of purchase, or install, whichever is latest.

HIGH EFFICIENCY PROCESS BOILER

Earn a rebate of up to \$80,000 for a steam boiler and up to \$60,000 for a new hot water boiler to replace a standard efficiency process boiler. Input rating may not exceed 20,000 MBH.

BOILER TYPE	COMBUSTION EFFICIENCY	UNIT REBATE
Hot Water	85%	\$2.50 per MBH
	90%	\$3.00 per MBH
Steam	83%	\$4.00 per MBH

BOILER ECONOMIZERS

Earn a rebate of up to \$70,000 for a new economizer on a process heating steam boiler. Input rating may not exceed 20.000 MBH.

ECONOMIZER TYPE	UNIT REBATE	
Feedwater	\$1.50 per MBH	
Condensing	\$3.50 per MBH	

PIPE/FITTING INSULATION

Earn a rebate of up to \$5 per linear foot or fitting of insulation on/from natural gas equipment. Pipe must be at least 0.5 inches in diameter; insulation materials/accessories must be installed on site and according to manufacturer's instructions.

TANK INSULATION

Earn a rebate for up to \$8 per square foot of fiberglass or foam insulation on liquid storage or transfer tank coupled to natural gas equipment. Insulation must be applied on-site.

INSULATION THICKNESS	USAGE	UNIT REBATE
1''-2''	High (Continuous)	\$4.00 per sq ft
More than 2"	High (Continuous)	\$8.00 per sq ft

BASE INCENTIVE RATES

The Industrial Savings, Training, Assistance, Rebate (Industrial STAR) Program offers up to \$2.00/therm for custom projects depending on project scope. Incentives are based on actual savings as demonstrated by post-installation verification.

Additional incentives may be available. Industrial STAR funds are limited and are available on a first-come, first-served basis. **Contact us for more information!**

Add-On Equipment	\$1.25	50% FEC
Accelerated Replacement	\$2.00	100% ARC

^{*} Incentives are capped based on full equipment cost (FEC), accelerated replacement cost (ARC), or incremental equipment cost (IEC), depending on equipment type. Incentives over \$500,000 are subject to additional SoCalGas review and approval.

OBTAIN CUSTOMPROJECT INCENTIVES

WHAT IS A CUSTOM PROJECT?

A custom project is a pre-approved upgrade, retrofit or new installation. Customized incentive dollars are based on how much energy the project saves. Typically, much larger in scope than a deemed or prescriptive project, custom projects can include a wide range of facilities, equipment, and project types.

WHO IS ELIGIBLE?

The program is open to eligible SoCalGas business customers who meet the following criteria:

- Receive natural gas from SoCalGas.
- Pay the Public Purpose Program (PPP) surcharge on their utility bills.
- NAICS codes 3111-3121 (Food Processing).

GET 0% FINANCING!

On-Bill Financing (OBF) is available at 0% interest for a term of up to 120 months. OBF must be combined with an incentive. The loan is designed to be "bill neutral" and paid back directly on your utility bill such that the monthly payment aligns with the cost savings from the energy efficient project.

HOW TO GET A CUSTOM PROJECT INCENTIVE

1 IDENTIFY, QUANTIFY, AND PRIORITIZE ENERGY EFFICIENCY OPPORTUNITIES

Enroll in the program by submitting a completed Industrial STAR Program Participation Agreement. Meet with an Industrial STAR Energy Coach to discuss ideas for improving energy efficiency and develop a list of potential projects. Your Energy Coach will identify the projects that qualify for incentives and help prioritize opportunities by quantifying the energy savings and cost impacts.

Your Energy Coach will help develop a Project Feasibility Study (PFS) for eligible projects. The PFS documents the opportunities in detail and collects required program information.

2 OBTAIN SOCALGAS APPROVAL

Your Energy Coach will work with you to develop and submit an Industrial STAR Custom Project Application. SoCalGas will review the application, and upon approval, issue a Conditional Incentive Reservation (CIR) that includes the estimated incentive amount. For customers pursuing OBF, your Energy Coach will also work with you to complete a Loan Agreement.

IMPORTANT:

Custom projects must be approved by SoCalGas before equipment is ordered, purchased or installed.

3 PURCHASE AND INSTALL EQUIPMENT

Once you receive a CIR, purchase and install the energy upgrade using your staff, contractor, or supplier of your choice.

After the system is fully installed and commissioned, your Energy Coach will work with you to document project costs and verify post-installation energy savings in an Installation Report.

4 RECEIVE

The Installation Report is reviewed and approved by SoCalGas, and an incentive check is issued based on final project costs and verified energy savings. For customers pursuing OBF, a loan modification may be in order to reflect the achieved energy savings and keep monthly billing neutral compared to pre-installation energy costs.

Customers will receive a short customer service survey as an opportunity to provide feedback on the Industrial STAR services and processes.
