Throughout response to Data Request No. Cal Advocates-SCG-A2506011-007, SoCalGas refers to “miscellaneous costs which include ... Outside Legal” and provides a footnote that “These miscellaneous costs are prorated across studies.”¹

QUESTION 2:

Provide invoices for “Outside Legal” services that are associated with costs included in this Application.

RESPONSE 2:

SoCalGas objects to this request on the grounds that it seeks information protected by the attorney-client privilege, the attorney work product doctrine, or any other applicable privilege or evidentiary doctrine.

SUPPLEMENTAL RESPONSE 2:

SoCalGas re-states and incorporates by reference previously stated objections. Subject to and without waiving the foregoing, SoCalGas responds as follows.

During the April 17, 2026 meet and confer, Cal Advocates acknowledged that it is not seeking privileged legal invoices. SoCalGas and Cal Advocates discussed whether SoCalGas could supplement its response to DR 7 with a breakdown of hours, hourly rates, and brief non-privileged descriptions of the legal support for Questions 1 through 7.

On April 29, 2026 Cal Advocates requested a rate sheet that lists the hours and hourly rates associated with the legal invoices. In response, SoCalGas proposed supplementing its response to Data Request 8, Question 2 with this information, rather than including it as part of its response to Data Request 7. Cal Advocates agreed to this approach.

See below for a breakdown of hours, total cost, and the resulting calculated hourly rate for each outside legal timekeeper. The average hourly rate reflects total cost divided by total hours worked for each timekeeper.
