

SOCALGAS' COMMITMENT

As the operator of the nation's largest gas infrastructure, serving more than 21 million customers, we believe every Californian deserves a clean, affordable, and resilient energy future.

In April 2018, the California Public Utilities Commission (CPUC) issued the **Order Instituting Rulemaking (OIR)** to Consider Strategies and Guidance for Climate Adaptation, Rulemaking 18-04-019.

This proceeding issued new guidelines for investor-owned utilities, like SoCalGas, to upgrade infrastructure, operations, and services to adapt to climate change including a vulnerability assessment of its infrastructure and the completion of a community engagement plan.

WHAT IS CLIMATE ADAPTATION?

As described in 18-04-019, climate adaptation is the ability of communities and utility companies to adapt to infrastructure to potential climate hazards.

PREPARING CALIFORNIA FOR THE FUTURE

SoCalGas is preparing for potential climate change impacts so we can continue to provide our customers with safe, reliable and affordable service. As part of this preparation, and as directed by the CPUC, SoCalGas is working with our communities to develop a Vulnerability Assessment and Community Engagement Plan.

WHAT IS A VULNERABILITY ASSESSMENT?

SoCalGas will examine the impacts of potential climate hazards on its infrastructure, operations, and services. This assessment enables SoCalGas to draft climate adaptation plans for future infrastructure needs.

WHAT IS A COMMUNITY ENGAGEMENT PLAN?

Your input is crucial to planning California's energy future. The Community Engagement Plan is the layout for how SoCalGas will engage with our communities, especially those that have been historically underrepresented, on climate adaptation related to the utilities' infrastructure, operations, and services.
