Contractor Collaborative Platform Expands Eligibility to Include Commercial and Multifamily Installations

The Contractor Collaborative Platform (CCP) provides a \$200 bonus for every qualifying energy-efficient natural gas central furnace and \$150 bonus for every qualifying energy-efficient natural gas tankless water heater participating contractors install within SoCalGas service territory.

The CCP has now expanded to include installations made at commercial and multifamily properties. Previously, the CCP was limited to installations made at single family residences only.

As part of the program, contractors must take an energy efficiency-training every six months, which will be provided at no-cost. While not a requirement, projects submitted for applicable CCP bonus processing are encouraged to

On-Bill Financing Loan Limit Increases to \$250K for Business and Multifamily Customers

The SoCalGas On-Bill Financing Program (OBF) offers zero-percent financing to non-residential customers making eligible energy efficiency upgrades to their facility. Effective immediately, business and multifamily customers' maximum OBF loan amount can be increased upon application from \$100,000 to \$250,000. Maximum potential loan terms remain at 10 years or useful equipment life, whichever is shorter.

There are no prepayment penalties or origination fees with OBF, and potential loan repayment is added to the customers' SoCalGas bill.
