

SoCalGas understands "page 9" to be the document bates labeled EP-SCG-2020-01.Q2 0000009, which is page 36 of the pdf provided by Cal Advocates and "page 4" to be page 17 of the pdf. Subject to its objection, SoCalGas responds as follows: The reference to "doc # 10672415" in the document bates labeled EP-SCG-2020-01.Q2 0000009 is to the JE Number 10672415.
