The California Public Utilities Commission (CPUC) will hold Evidentiary Hearing(s) at the time and place below regarding Southern California Gas Company (SoCalGas) application **A.22-04-011**.

At the/these Evidentiary Hearing(s), SoCalGas, consumer advocacy groups, and other parties to this proceeding testify before a CPUC Administrative Law Judge regarding SoCalGas's request. The public can attend and listen to the hearing(s) but are not allowed to testify.

### **Why is SoCalGas requesting this rate change?**

On April 20, 2022, SoCalGas filed its Cost of Capital Application **A.22-04-011** with the CPUC. The application is requesting that the CPUC determine the appropriate rate of return necessary to attract capital at reasonable rates and compensate the utility for business, regulatory, and financial risks. If approved, SoCalGas's overall authorized rate of return would increase from 7.30% to 7.60%.

If the CPUC approves this application, SoCalGas will recover forecasted costs in gas rates beginning January 1, 2023, through 2025. This will impact your monthly bill.

### **How could this affect my monthly gas rates?**

If SoCalGas's request is approved by the CPUC, the average residential monthly bill using 35 therms per month would increase by approximately \$0.63 or 1.1% per month in 2023.

### **How does the rest of this process work?**

This application has been assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding are currently reviewing SoCalGas's application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
