



I urge you to stop your proposed Ventura Compressor Station expansion and to shut it down. This facility has negative health impacts on our community and puts our neighborhood at risk from explosions, leaks, and air pollution. We do not want this compressor in our neighborhood, especially near our kids at EP Foster Elementary; it's the only compressor located so close to a community in the state of California. We ask that you make the right choice to protect our community and shut down this facility.

The Westside of Ventura already suffers from some of the highest levels of pollution in California, as well as the health effects that come with that, like asthma and cancer. This facility should not be this close to homes and schools in the first place, and an expansion for decades longer is totally unacceptable. SoCalGas representatives have not revealed evidence of a need for expansion in the first place.



Since last I wrote, over two weeks ago I've yet to receive the courtesy of a reply. In my mind a straight line is evident between the minor "muffling" of the vibration occurence at my residence since the changing of the pressure regulator at the outside meter and the fact that my home is vibrating in response to - gas transmission. As previously stated, this vibration is a new occurence at my home that I've resided in for over 10 years with no such occurence prior to it starting up approximately the second week in Feb.2021.

- Since Oct. 27, 2021 when I last wrote and updated you the vibration continued til 10pm when I went to bed on 10/27/21. The following morning TH. 10/28 at 6:30, 10:30 and at 12:15pm it was on, continuing until apprx. 2;45 or 3p when it was either off or extremely low. It has both building and diminishing levels, til it peaks and runs for hours then diminishes until ending and then completely off. That day it came to my attention that a formerly, small dropped / cracked portion of concrete was now noticeably lowered on the walkway leading to my porch. I wondered if this was related to a neighbors complaint ot a widening crack at her house and another neighbors fear of a sink hole developing in her yard. I will have to check with them and get updates. TH. eve 10/28 still off til bed and through the night. On Fri. 10/29 I first began to hear it, then felt it about 12:30/12:50pm and

by 2:50pm it had gained considerably in noise and vibration, continuing until 10p, when I retired. SA. morning, 10/30 it was not apparent at 6:45 then was on at 8:30am thru Sun. 10/31 at 9:30/10am, then off the rest of Sunday day and night. Off on Monday 11/1, TU. 11/2 and WE. 11/3 - WOW, what blessed relief! My ears are able to return to normal, I'm able to fall asleep without aid, sleep through the night and wake without headaches, dizziness and aching joints, not feeling or hearing the low hum in my ears that accompanies when it is occuring and causing considerable anxiety!! I had none of these issues prior to the start of the vibration at this house. Thurs. am 11/4 when returning the garbage cans into place beside the house, the gas meter was hissing, tho there was no smell of gas. While it was going on TH am it was very low grade, requiring real attention paid to feel it, so the slow build up which had peaked to the high level in the 11 am hour and continued til bed and was on Fri 11/5, again super low in the morning til much more strong at 9:30 thru noon time. I was away part of that day and then it was off at 6:45 ish p.m.. Sat. 11/6 off on awakening, came on low level at 7:30 ish and built til strong by 10:30am thru to retiring that evening. On Sund. 11/7 all day and night and on at 3am Mon. 11/8 and 6a and 7:30a causing sharp ear pain and a piercing noise in my ear at one point then diminshing and low at 10am, still low at 12:30pm & 2:40

though I hear the low roar. By 8:10pm I noticed it to be completely off. Tuesday 11/9 I'm awoken by it at 1a,3a, 5a and 6:30am - experienced headache and dizziness. It continued on Tues. til sometime between 5:30 and 6:30 pm when it was off only a short time til 8pm then returned low level thru Tues night and on awakening Wed 11/10 low level until off with no noise or vibration evident in the later afternoon about 3:30/40pm. Blessedly it was off on TH. 11/12 all day and evening, then resumed at 5:30am today FR. 11/12 apparent and low at first, then built up by 9:15am and going / apparent now, again bothering ears and felt when sitting on furniture, such as the desk chair I'm in, the kitchen stools, on the bed, on the sofa and in heavily upholstered easy chairs.

I believe there is an accompanying gas co. claim number of that occurence.



I am continuing to be disturbed by this sensation, physically and mentally as it has taken away my quality of life and caused fears re; the ability to sell or rent the property, which at any time, but especially in these days and times is very upsetting. Who can I speak to in order to move

forward and reach some type of agreeable resolution to make my house STOP VIBRATING??

I ordered a conversion kit for my water heater - \$50 w/ S&H and then paid a plumber to visit - \$125 - only to learn that the water heater WAS in fact set up for use with natural gas as was evident by the blue flame of the pilot and his look at the unit. Further inconvenience and expenditure to me while the hot water was not used, then money spent for nothing. I have endured this for nine long months, spent time, energy and money while working, worrying about older parents across the country and trying to be there for them in any way I can - to attempt to first discover then try to find someone who can make this go away - a problem that I did not bring about, nor have I been able to fix!!. I am at the end of my patience and will be seeking outside assistance if I do not get a timely and helpful response from the gas company with relation to this claim and the problems this is causing me. very low low and same during the day TH., 2/10/2022, however more noticeable than Wed. & increasing and becoming more apparent by Thursday evening, increasing around 6pm and able to be felt through furnishings and the floor, ascending, continuing during the night - a very bad

night of sleep being the result as it woke me twice - & continued thru the day Friday with both physical and audible sensations, then diminishing down and ending about 8pm Friday the 11th.

Rewind to Tuesday Feb. 8, 2022 after three utterly PEACEFUL days - Sat. the 5th, Sun. the 6th and Mon. the 7th, the house began trembling again - like a frightened animal is one way to describe it, like the fine tremble of a tuning fork, like a motor humming under your home that you cant find the switch to turn OFF, like the old, put a quarter in massaging beds found in motels,

Still on FR. 1/21/22 at 5:45am - strong, disruptive, then beginning to peter out, noon, one-ish and definitely off sometime in the 2pm hour, still off at 7pm and 10:45pm. Off all day SA., 1/22/22, resuming early SU., 1/23/22 - 3am(?), 4am(?) and evident on waking at 6:45am. Continued on thru out SU., thru the night and on waking MO., 1/24/22, 7:20am. Then I thought it had ended between 8 - 9am, the 24th but was mistaken. It was still going at a low, low ebb until I was able to determine it was definitely OFF at 2:30pm.. It remained off through the day TU. 1/25/22 not resuming until about 9/10pm & just in

time to try to go to sleep, continuing at a low level through WE. 1/26 with accompanying ear discomfort. OFF TH, 1/27/22 at 6:45am all thru the day TH, & still off FR, 1/28/22 then back ON SA. 1/29/22, again low and insidious and awful to live in thru that evening when at 8:40 pm it was going HARD - (see above)! I have documentation of occurence back to the last lengthy e-mail I forwarded detailing it to you. In fact I have it back quite far - almost to the beginning.

OWN HOME, where there is work I need to be producing in order to maintain my current employment, things I need to be able to do AT HOME to maintain my property

- in short to earn a living and care for the property!! I am being DRIVEN FROM MY OWN home by this continuing vibration, that is UTTERLY and COMPLETELY OUT

The fact remains that after some significant change in operations that began mid-February of 2021 in proximity near to my home, after the gas company had spent time & posted notice of work to the high pressure lines along Ventura Ave. in late 2020, early 2021 my house & myself have, are and continue to undergo prolonged periods of vibration exposure. The vibration causes sleeplessness, anxiety and due to both those things an incredible loss of focus & mental acuity. Lord only knows the long term damage being sustained by the physical structure of the house and other utilities/systems within. Except for a gas technician who changed the regulator at the gas meter & checked operations of gas powered systems within no one has been to this house in response to the claim. 
