

### 2020 REBATE APPLICATION NOW AVAILABLE

The **2020 Energy Efficiency Rebates for Business application** is now available. Most of the program conditions and eligibility requirements are unchanged from last year, with the following exceptions:

- **Pool Covers:** The customer must not have had a pool cover in the past six months (before installing the new pool cover). (This is a new eligibility requirement; the other requirements from 2019 remain in place.)
- **Laundry Natural Gas Modulating Valves:** Rebates are limited to the first 250 kits at coin-operated laundries and the first 1,000 kits at all other facilities.
- **Infrared Film:** Rebate amount decreased from \$.05 to \$.02 per square foot.
- **Greenhouse Curtains:** Rebate amount increased from \$.20 to \$.30 per square foot.
- **Combi Ovens (15-28 pans):** Rebate amount increased from \$1,450 to \$1,800 per oven.
- **Pressureless Steamer:** Rebate amount decreased from \$2,500 to \$1,800 per compartment.
